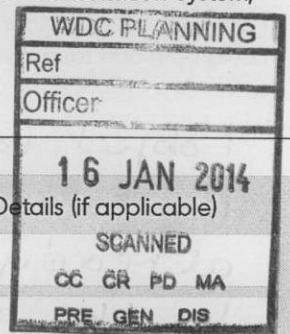

I object to any more houses being built in Radford Semell. I think that Radford has already taken its fair share of housing in the past.
