We reserve our position on this and it will depend on other matters and representations submitted as part of the process. We feel our attendance would be beneficial to be able to illustrate the deficiencies and inappropriateness of sections of the Plan. We would certainly wish to attend the pre-Inquiry meeting. At that stage, depending on all other submissions made, we would indicate at that juncture whether we feel our continuing participation in your examination is necessary and reasonable. You may at that stage be prepared to accept that our client's position has been protected by previous comments which have been submitted in this process, further comments submitted herewith and further written evidence which will be provided for the Inquiry process.

We wish to make it clear at this stage that we have not replicated all previous comments and reservations that we have expressed in the formal process of evaluating the Plan. We can resubmit these but we wish them to stand as part of the evidence base for the Local Plan determination. Also at this stage we are not entirely clear of the extent to which the Inspector will be considering in detail site allocations. We do not feel this process has been properly managed and consultations have been bypassed.
