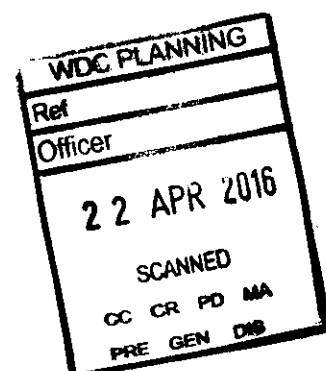

The modifications in plans with increased housing numbers have been issued without proper consultation with the local community and without regard to the burden on the existing infrastructure. No definite assurance of what will be done prior to any development for improving the local road network, safety from increasing accidents in the H28 blackspot (A4177), easing the traffic congestion, overcoming the existing poor drainage issues and addressing the poor air quality from this main road area. A new access road on the notorious road bend is for example a crazy & thoughtless suggestion. No school accommodation or health services included and no identification of 'open spaces' in the proposal. No plan for the housing layout. No regard for greenbelt or sustainability in the long-term.

We are being asked to consider supporting just an outline concept which shows weakness in preparation and is unsound. It is open to any further distortion from others or organisations. In view of comments at 7 above - The plan needs to be very clear and bear a required commitment that developers and WDC will address all the key infrastructure needs. Commonsense should rule over how many homes should be safely situated in locations H28 & H53. Regard should be given that the A4177 is an already highly congested main route into historic Warwick. Regard for suitable development style in the greenbelt and the Towns area which supports the main town is also key. To make the local plan work local people need to be listened to.

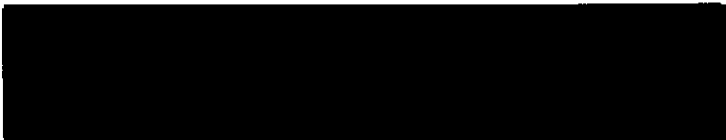

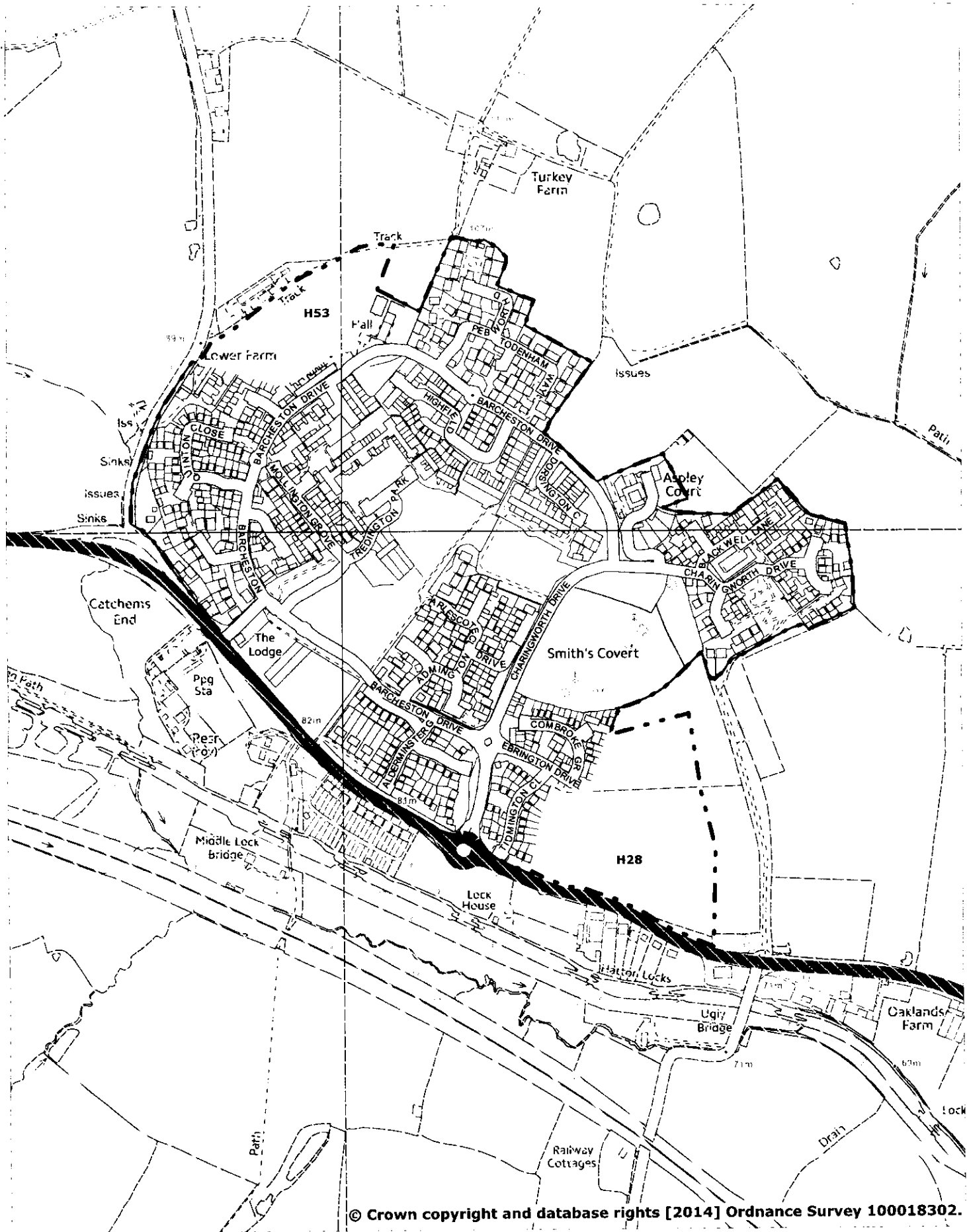
