I am objecting to the proposed construction of 70-90 properties on the two fields to the rear of Combroke Grove, Hatton Park. There currently is not the infrastructure to support a further increase in traffic and residents in the area.

The volume of traffic on the Birmingham Road is currently an issue. Trying to get off Hatton Park in a morning is already getting worse. Initially you have to navigate past a line of cars which belong to parents on the road adjacent the Birmingham road island while they wait with their children to be collected by the school bus at the bus stop and then some mornings it's a real challenge trying to get onto the Birmingham Road due to the sheer volume of traffic which use this road.

I purchased my property in 1998 when they were first built. One of the reasons for me buying this property was due to the wonderful views across open countryside and the privacy due to the location. If houses were to be built on these fields my neighbours and I would not only lose the wonderful views but also our privacy.

We currently have abundant wildlife and birds which frequent the fields and our gardens. There would be a loss of wildlife/bird habitat if the fields were developed on and the hedgerow which currently divides the fields is removed. There are currently yellowhammers, skylarks, black caps, blackbirds, robins, song thrush, hedge sparrows, pheasants, red legged partridge and lapwings (to name but a few) which nest in these fields and hedgerow.

There would also be a problem with noise and dust from the construction of the houses which would last for some considerable time and would not allow us to enjoy peace and quiet in our own back gardens, especially during the summer months.
