This representation refers to the settlement of Bishops Tachbrook

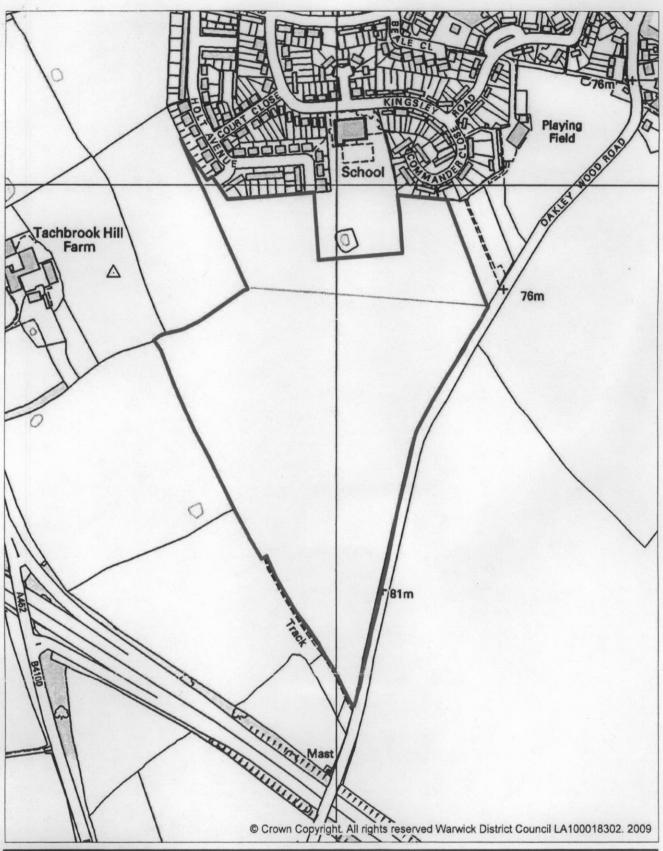
We act as agents and planning consultants to Mr and Mrs J. Wright who are the owners of the land we have shown edged in red upon the attached plan.
