## Part B - Commenting on the Stratford Road Gypsy and Traveller Preferred Site

The policy in the Draft Local Plan will list the criteria by which Gypsy and Traveller sites will be judged for suitability and sustainability. These are the criteria:

- the site is within reasonable distance of schools, GP surgeries, dentists, hospitals, shops a) and community facilities;
- the site has good access to the major road network; b)
- the site is of a suitable size to accommodate between 5 and 15 pitches for permanent sites or 12 pitches for transitisites;
- it can be demonstrated that infrastructure requirements can be adequately met; and

e) there is potential for the site to be adequately screened.				
What is the nature of your representation? Support Object Comment  Please set out full details of your objection or representation of support with reference to the criteria above.				
(b) Unless access is via the island used by STWA, the only access is from the old Barford road onto a dangerous and blind bend. The old Barford road is always congested and the police have in the past doubted that emergency vehicles could pass. The old road is a major path for walkers and cyclists to the footbridge over the motorway. The road would not cope with another 45 cars, trucks and caravans.				
(d) My existing farm track to the site cannot meet the requirements and should not even be considered. It is only 3 metres wide, national guidelines require 5 metres, and it cannot be widened because there is the brook on one side and my verge, which is not available, and my 51 mature trees on the other side. National guidelines require overtaking spaces and there is not anywhere on the trackfor overtaking; additional land will not be made available by me. The track is usually in a poor state of repair; the weight of an additional 45 vehicles would make it unusable. Some delivery drivers already will not use it and the refuse collection drivers refuse to use it, so that there is the prospect of another 30+ wheelie bins having to be placed on the old Barford road.  Access is also hampered for high sided vehicles if I do not cut back my trees. It follows that any contractors or construction vehicles wishing to attend the site to put in the infrastructure will be hampered severely and probably prevented from reaching the site.				
The potential costs of laying in water, sewerage etc. have not been identified and it cannot be said that the costs will be met adequately.  Furthermore, the laying in of the infrastructure would almost certainly have to go over my land and it is not available.				
(e) The M40 can be viewed to the south west from the site when I have finished cutting and laying my hedge, and the prevailing wind from that direction carries the noise from the M40 straight to the site. Noise levels are already above guidelines for residential development (the report obtained by Warwick D C is flawed) and no mention is made of screening the nosiest side.  National guidelines require a site to be safe for families and children. The site backs on to the River Avon and it is very accessible. The river is not safe for children and no mention is made of how the site will be screened from the river.				
National guidelines require that sites should not become enclosed ghettos; the site will become a ghetto if it is to be screened on all its sides to make the river banks secure and, in a forlorn attempt, to cut out the noise of the M40.
