## Part B - Commenting on the Stratford Road Gypsy and Traveller Preferred Site

The policy in the Draft Local Plan will list the criteria by which Gypsy and Traveller sites will be judged for suitability and sustainability. These are the criteria:

- a) the site is within reasonable distance of schools, GP surgeries, dentists, hospitals, shops and community facilities;
- b) the site has good access to the major road network;
- c) the site is of a suitable size to accommodate between 5 and 15 pitches for permanent sites or 12 pitches for transit sites;
- it can be demonstrated that infrastructure requirements can be adequately met;

- e) there is potential for the site to be adequately screened.

I object to the Gypsy and Traveller site being built on Stratford Road for the following reasons with reference to the criteria above:  a) Reasonable distance from services: - Whilst there are services nearby, it is not clear whether they are able to sustain the increase in population due to the proposed Gypsy and Traveller site. In the councils own Sustainability Assessment this section is graded as '?' and states that the effect on the economy in uncertain at this stage. This is not an acceptable assessment of the effect that the Gypsy and Traveller site will have on the local services. There are currently limited services in the local area and it is unclear whether they will be able to support the potential increase in population, for example it is likely that there will not be enough places at local schools to support the increase in children which will have a detrimental effect on the children that already live in the local area, forcing the Gypsy and Traveller children and/or other local children to travel further afield. As a local resident I have also found it very difficult to access a local dentist under the NHS and				
therefore it is likely that new residents will also find this an issue. It is also likely that due to the negative perception of Gypsies and Travellers this will have a negative impact on the local community as a whole, for example decreasing the demand for the already largely undeveloped Tournament Fields Business Park.				
b) Good access to local road networks:- It is clear that the site is near to the A46/M40 junction, however the exact details of the access to the plot inadequately addressed, and states that 'advice expected soon'. Again, this is unacceptable to plan a site and hold a consultation without the necessary information. The current narrow farm track to the land is currently inadequate and would not provide access for emergency vehicles as outlined in the government guidelines regarding Gypsy Traveller sites. Access to the site from Longbridge would also place the main entrance of the site next to a Grade II listed building which is located on a dangerous bend with poor visibility to motorists putting the public at increased risk of serious road traffic accidents.				
c) Suitable size – The site is of suitable size, however with size of plot comes increased residents to the local area, with an unknown impact on the local economy (See points in a) and also an uncertainty with regards to whether the access is acceptable (See points in b) and whether the infrastructure requirements can be met (see points in d). All of this is unclear and unacceptable with regards to a plan.				
d) Infrastructure requirements can be met: - The councils own assessment states that air, soil and water quality are of significant concern and the development of a Gypsy and Traveller site could have a potential negative effect. Although it claims this can be 'mitigated' there is little further detail with regards to this. A site close to a sewage works and a busy motorway network will require a significant cost to rectify these aspects to ensure safety of the Gypsy and Traveller community residing in the area to ensure their safety. There is also a flood risk associated with the site and according to the government guidelines, sites should not be built where there is probability that flooding will occur. Whilst 'mitigation work' has been alluded to, there is no

e) I am unaware of any information as to how the site will be adequately screened. The Stratford Road site is the main entrance road into Warwick from the motorway and a high amount of tourists travel up the road. Even with a screen, I believe that the Gypsy and Traveller site will still be visible to the people visiting Warwick and will have a negative impact on the impression of the beautiful medieval town and ultimately on the popularity of it.
There is therefore reason to object to the Gypsy and Traveller site being built on the Stratford Road site in Warwick for all of the criteria points that have been noted above. There is also not enough information or thought gone into the details of the plan. It is imperative that it does not go ahead.
