Part B - Commenting on the Stratford Road Gypsy and Traveller Preferred Site

The policy in the Draft Local Plan will list the criteria by which Gypsy and Traveller sites will be judged for suitability and sustainability. These are the criteria:

- a) the site is within reasonable distance of schools, GP surgeries, dentists, hospitals, shops and community facilities;
- b) the site has good access to the major road network;
- c) the site is of a suitable size to accommodate between 5 and 15 pitches for permanent sites or 12 pitches for transit sites;
- it can be demonstrated that infrastructure requirements can be adequately met;

- e) there is potential for the site to be adequately screened.

I am of the opinion that the proposed location off Stratford Road is flawed for the following reasons:				
Location				
The proposed site is located between three obvious hazards, the M40, a sewage processing plant and the river Avon. This is a site where it is proposed that families will live. As the mother of young children, I cannot think of a worse location in which to raise my family. There are the obvious dangers of someone falling into the river, much more likely where children, who are naturally inquisitive, are concerned. Add to this the environmental concerns of this location: We can usually hear the traffic on the M40 from our house, and quite often we can smell the sewage works. The air quality from the traffic in this location is, I would have thought, very poor. The constant noise from the motorway would also be intrusive on the residents' day to day life.				
The government's guidelines on planning gypsy and traveller sites state that:				
"It is essential that the location of a site will provide a safe environment for the residents. Sites should not be situated near refuse sites, industrial processes or other hazardous places, as this will obviously have a detrimental effect on the general health and well-being of the residents and pose particular safety risks for young children." This location clearly falls foul of these guidelines.				
Flood risk				
The location is adjacent to the river Avon on a flood plain. My home is located some distance from the river. but we have been able to see flooding over the fields at the rear of our house on several occasions in the six years that we have owned the house. This shows that flooding is, if not a regular occurrence, a reasonably foreseeable occurrence in the event of heavy rain. The consultation document states that the flood risk is an area of concern, but that a technical report endorsed by the Environment Agency stating that the risk of flooding can be mitigated. It is not clear how the flood risk can be completely removed. I recall that last year there was flooding on the Southbound A46, approaching the Longbridge junction, this was around the time that the extensive culverting work was completed. These two events may be completely unrelated but suggest to me that even the best laid plans do not always give the desired or expected outcome. The proposed site would involve a large area of hardstanding, which would increase the risk.

The location, being in an area prone to flooding, is therefore included in the "other hazardous places" category in the government's guidelines referred to above. These same guidelines state that "Caravan sites for permanent residence are considered highly vulnerable" and should not be permitted in areas where there is a high probability that flooding will occur (zone 3 areas)". The Council's sustainability agreement confirms that the site is situated on a designated flood plain within flood zones 2 and 3 (3 being the most hazardous).

Access

I understand that there are only two proposed means of access to the site; either across land belonging to Severn Trent, and down the lane behind the Porridge Pot pub and along a farm track. My understanding is that at this stage Severn Trent have indicated that they would be unwilling to grant an easement over their land, or sell land to the Council for access to be provided. It is unclear whether it would be possible to compulsorily purchase land for this purpose. However if this were to be possible, such a course of action is likely to be costly and time consuming. As it is the Council's priority to provide these sites as soon as possible (by next year) it seems that this is not feasible. The existing lane behind the Porridge Pot is situated on a bend on a very fast road leading off Longbridge island. Aside from the obvious issues of the increase of traffic at this junction, there are surely issues of problems for access for emergency vehicles. I understand that roads should be of a minimum width to allow such vehicles to pass. Aside from this is the fact that residents would need to use this lane with, on occasion, vehicles with or without caravans and/or motorhomes.

Planning process

This proposed site was not included in the original proposed sites (in excess of 20) which were put forward by the Council last year. It is not clear on what basis this site was selected, and why it was not included in the original proposal. This has not been communicated to members of the public. Indeed it has gone from not being on the shortlist at the start of 2014 to one of three preferred sites. I believe that it could be argued that this failure could mean that the selection of the site could be open to judicial review, and could also be subject to an action for breach of human rights legislation.

The government states that 15 is the maximum number of pitches to be allowed on one site, the ideal being smaller, with the preference being for there to be a number of smaller sites. Not only have the Council added this site late in the day, they seem to be trying to meet their obligations with as few sites as possible. The fact that this large site seems to have been added at the last minute suggests that the Council is trying to sneak this in" through the back door".

Finally, I could like to state that I fully support and endorse the contents of the objection document submitted by the Chase Meadows Residents Association.
