Save our sheep field from development! Please act before Sunday April 17th

Hello neighbours

Following our discussions and the note we popped through your letterbox this weekend, we need to act **NOW** to prevent **55 houses being built on the sheep field** below the village hall car park. Here is the form we promised if you'd like to object to the field's inclusion in the new Warwick District Council Local Plan.

It will carry more weight with the Inspector if we all complete our own forms, so we are issuing this handy sheet listing the sections that need to be filled in and a selection of what we believe to be valid objections (you may have others). Please do photocopy these for all members of your household to maximise the impact of our objections. The inspector will take into account EVERY LETTER from every household.

The Oakland Farm site, which was under consideration as a traveller site, together with the remainder of that farm could be used for housing instead, although it is acknowledged this does not address the concerns over increased traffic on the Birmingham Road or lack of public transport infrastructure, schools and other facilities. It does however address the issues of access, as the Birmingham Road is not subject to traffic calming or children's play areas and is currently used by large commercial vehicles.

OBJECTIONS:

- 1. Barcheston Drive is too narrow for lorry and heavy plant movements during the construction phase. The bus already struggles to negotiate the traffic calming features, particularly with the presence of parked cars. They may also be obliged to use the grass verges and pathways, presenting a danger to pedestrians and destroying the established walkways and cycle paths.
- 2. Proposed access from the village hall car park is very steep. In order to provide sufficient road infrastructure to counteract the steep gradient additional land above that highlighted in the proposal would need to be acquired. This will impact on the village hall, the neighbouring play area, planted orchard, sports facilities and the number of parking spaces available for the village hall. Additional car parking would also need to be provided to compensate the loss of spaces as the proposed access is through the village hall car park.
- 3. The children's play area would become dangerous as it would be next to an access road and the resultant increase in traffic to the new houses. Appropriate fences etc would need to be put in place to prevent children from running out into the road. Having said this, a playground on the corner of a junction can hardly be described as safe and sensible. The location of the junction is far from ideal.
- 4. The wider infrastructure (Birmingham Road) will struggle to support the additional traffic inevitably generated by the occupiers of 55 homes. At peak times the road is already congested with commuters and parents driving children to and from school.
- 5. There have been a number of fatalities and serious accidents on the Birmingham Road in recent years and an increase in traffic volume will increase the likelihood of these occurring
- 6. From a wider viewpoint the projections for housing need in the region are based on a blip in demand and growth will not necessarily follow the same trajectory, hence we may not need as many houses as forecast. With this in mind, we question the decision to remove the green belt as a result of so called "special circumstances" to support additional housing needs.
- 7. The site is unsustainable environmentally as the lack of local infrastructure (public transport, schools, shops) requires additional car use and therefore does not comply with the National Planning Policy Framework's requirement to secure sustainable development.
- 8. The Local Plan has not identified the necessary infrastructure needed to support the level of new residential development for the sites allocated in the Plan, for example, new schools, health facilities and a better road infrastructure.
