I AM A RESIDENT OF LEICESTER LANE, 18 YEARS OLD AND SHOCKED TO HEAR THAT MY LOCAL COUNCIL PROPOSES TO INSENSITIVELY AND MONSTROUGLY DEVELOP HOUSING AND INFRINGE ON THE BEAUTIFUL AND VALUABLE GREEN BELT LAND.

DEFINED BY GREEN BELT UK POLITICS, GREEN BELT LAND IS "KEPT IN RESERVE FOR OPEN SPACE". ITS MAIN PURPOSE IS TO PROTECT THE LAND FROM URBAN SPRAWL AND "MAINTAIN THE DESIGNATED AREA FOR FORESTRY AND AGRICULTURE, AS WELL AS TO PROVIDE HABITAT FOR WILDLIFE", IT SHIELDS THE UNIQUE CHARACTER OF RURAL COMMUNITIES FROM CALLOUS CONTEMPORARY DEVELOPMENT AND PROVIDES ACCESS TO OPEN SPACE. THERE ARE ALSO OPPORTUNITIES FOR OUTDOOR LEISURE ACTIVITIES LIKE CYCLING AND WALKING IN CLEANER AIR, AS THE COUNCIL ITSELF HAS ADMITTED AS RECENTLY AS MAY 2012, THAT SOME CENTRAL PARTS OF LEAMINGTON SPA SUCH AS "HIGH STREET, CLEMENS STREET AND BATH STREET" ARE "A LIKELY BREACH OF THE NITROGEN DIOXIDE (ANNUAL MEAN) OBJECTIVE AS SPECIFIED IN THE AIR QUAUTY REGULATIONS" FOR ENGLAND AND WALES, 2000.

GREEN BELT COVERS A MERE 13% OF LAND IN ENGLAND, A VERY SMALL AND EMBARRASSING PROPORTION WHEN YOU CONSIDER WE PRIDE OURSELVES ON OUR GREEN AND PLEASANT LAND, AND ARE SEEN LAGGING FAR BEHIND OTHER COUNTRIES IN THIS AREA. WE SHOULD NOT BE INVADING OR

EVEN MEANINGLESSLY CHIPPING AWAY AT ANY GREEN BELT LAND, AS ONCE WE START, IT WILL ONLY NEEDLESSLY CONTINUE.

WE HAVE BENEFITTED A GREAT DEAL IN THE LAST 50 YEARS FROM GREEN BELT LAND AND ANY DEVELOPMENT ON THIS LAND WOULD ONLY BE DETRIMENTAL TO US. THE A452 DUAL CARRIAGEWAY WOULD ONLY CAUSE CONGESTION AND POLLUTION, ESPECIALLY AT PEAK TIMES, AND THE NORTH OF LEAMINGTON WOULD LOSE ITS PICTURESQUE CHARM AND BEAUTY. THE NEW PLANS FOR INDUSTRY AND INCOME WOULD NOT BE VIRTUOUS FOR LOCAL AND INDEPENDENT TRADE IN THE LEAMINGTON AND KENILWORTH AREA, ALSO PART OF THE ALLURE AND CHARACTER OF THE AREA. A LOSS IN AGRICULTURE, QUALITY OF LIFE AND COUNTRYSIDE ENJOYMENT ARE ALSO EXTREMELY FORSEEABLE WITH THE CURRENT PLANS FOR DEVELOPMENT. THE PROPOSED NORTHERN RELIEF ROAD WOULD ENCOURAGE MORE UNNECESSARY GROWTH, CLOSE TO THE FLOODPLAINS OF THE RIVER AVON, ALSO A COSTLY AND ILL-ADVISED VENTURE. DEVELOPMENT ON BLACKDOWN AND OLD MILVERTON IS TOO COSTLY AND UNSUSTAINABLE, REARING THE PROPOSED DEVELOPMENT RIDICULOUS WHEN THERE ARE OTHER MORE SUSTAINABLE OPTIONS, TO THE SOUTH OF LEAMINGTON FOR EXAMPLE.

GREEN BELT LAND, AS THE HARM TO THE SPACE AND SURROUNDING AREAS WOULD SEVERELY OUTWEIGH ANY BENEFITS THAT MAY ARISE. THE PRECEDING '2009 CORE STRATEGY' CONCLUDING MORE SUITABLE, CHEAPER AND SUSTAINABLE AREAS IN THE SOUTH OF LEAMINGTON SPA SHOULD BE ADHERED TO, IGNORING THE DEVELOPER'S COMPLAINTS OF LACK OF EXTREME FINANCIAL GAIN AS THIS IS NOT A 'VERY SPECIAL CIRCUMSTANCE' IN WHICH TO ALTERNATIVELY DEVELOP ON GREEN BELT LAND, THE CURRENT PROPOSAL IGNORES 'WARWICK DISTRICT COUNCIL'S' GREEN BELT STUDY' OF THE LAND AT OLD MILVERTON AND

BLACKDOWN, WHICH DETERMINED THAT THESE REGIONS HAVE HIGH VALUE AS GREEN BELT LAND, WARWICK DISTRICT COUNCIL ALSO REVEALED A HOUSING BUFFER OF 1400 HOUSES IN THEIR PROPOSAL AND IF THAT QUANTITY WAS REMOVED, THERE WOULD BE NO NEED FOR ANY DEVELOPMENT ON BLACKDOWN AND OLD MILVERTON.
