APPLICATION FOR THE DESIGNATION OF A NEIGHBOURHOOD PLAN

I refer to my letter of 2nd. October 2012 and to Warwick District Council's agreement to the designation of land in Old Milverton and Blackdown Parishes as a Neighbourhood Plan. Subsequently, the boundaries of Old Milverton Parish have been amended and accordingly, I make a new application as follows for the designation of the area within the new boundaries.

In accordance with the Statutory Instrument, Town and Country Planning England: Neighbourhood Planning (England) Regulations 2012, this Parish Council makes formal application to Warwick District Council for the designation of the land which will constitute the area in the Neighbourhood Plan being prepared by the Parish Council under the statutory regime for neighbourhood planning, made under the Localities Act 2011.

In accordance with Part 2 of The Neighbourhood Planning (General) Regulations 2012, paragraph 5(1), this application submits:

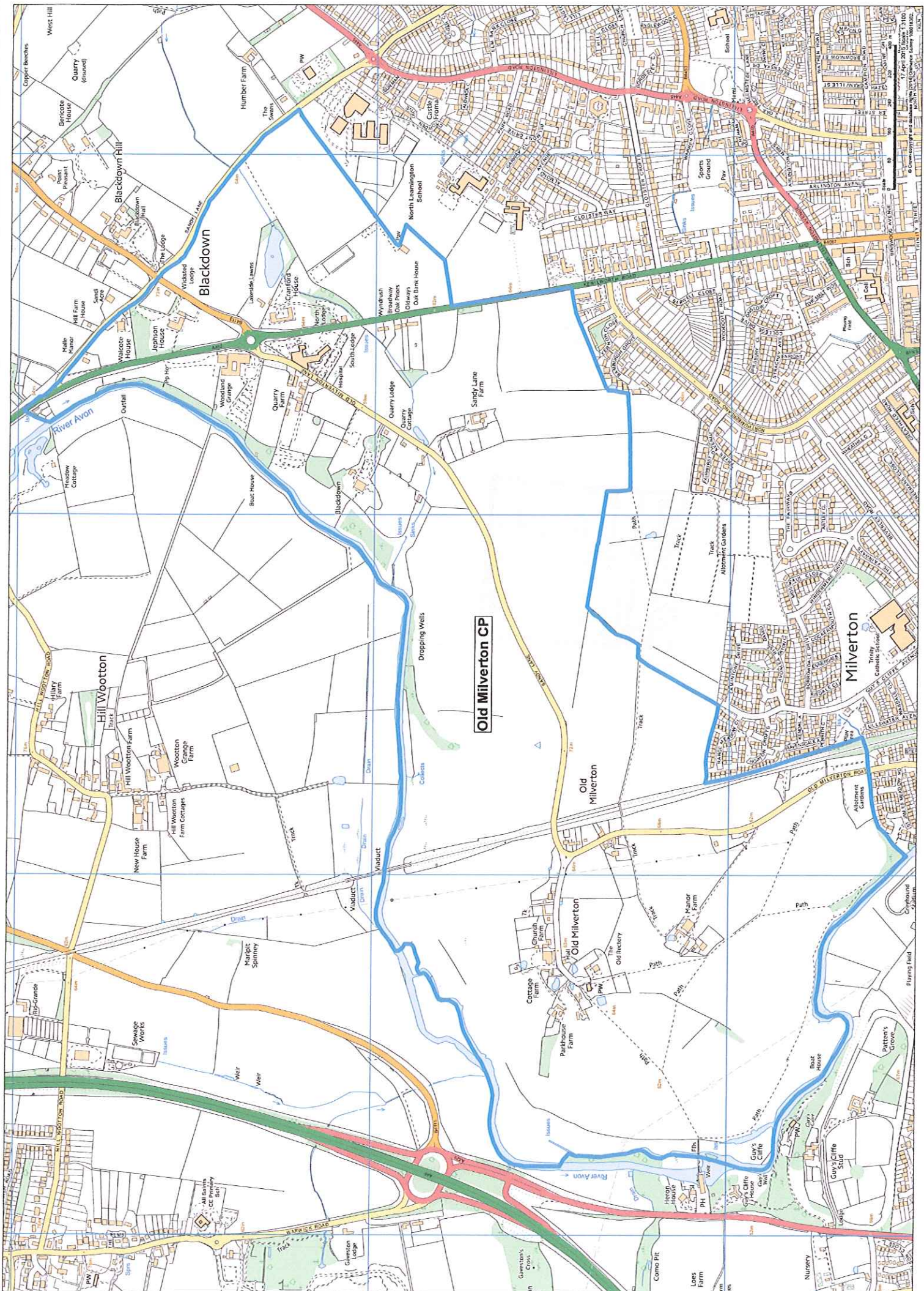
- (a). a map identifying the area to which the area application relates, being the ward boundaries of the two Parishes of Old Milverton and of Blackdown.
- (b). that, in considering the development of a Neighbourhood Plan for the plan period of 15 years, recognising both the rural nature and the needs of the populated parts of the parishes, it is essential to balance demand on all parts of the locality so that the most appropriate development plan is produced for the whole of the parishes.
- (c). that, Old Milverton and Blackdown Joint Parish Council is the relevant body for the purposes of the Town and Country Planning Act 1990, section 61g(2) as specified by paragraph 2(a) of Schedule 9 of the Localism Act 2011 for the preparation of a Neighbourhood Plan, being, by virtue of section 61f paragraph (4), the only organisation which can be so designated when the area for the Neighbourhood Plan consists of the whole area of the Joint Parish Council.

The Parish Council requests that you commence processing this application as set out in paragraph 6 of part 2 of the said Regulations.
