RPS acts on behalf of Lenco Investments Ltd which is the controlling landowner for the Land South of Baginton (SHLAA reference C10)

Paragraph 4.1.1 refers to interim level of housing growth of 12,300 dwellings between 2011 and 2029 based upon Warwick's own need. The Council has indicated that this figure may change once the joint Strategic Housing Market Assessment (SHMA) is published in August 2013. Given the evidence and that this is an interim figure, it has to be accepted that the figure will indeed change and that the 12,300 is not sufficiently robust as a housing requirement for Warwick. This is particularly the case as it contains no cross boundary element to it. In this context, it is very clear from the examination process for the Coventry Local Plan/Core Strategy and the subsequent reasons for the withdrawal of the Core Strategy that the authority has a significant level of unmet need and that cross boundary arrangements will need to be implemented to facilitate the needs of Coventry in Warwick. The fact that the 12,300 is an interim figure is evidence that Warwick District Council at this stage is unable to fix a definitive figure for its strategy given that it will have to accept additional need from Coventry and plan on the basis of a SHMA, in accordance with the NPPF.

RPS on behalf of Lenco Investments, therefore supports the increase in housing from the 10,800 dwellings in the previous version of the plan to this Preferred Options consultation document. However, the evidence illustrates that 12,300 dwellings is still insufficient to meet Warwick's own housing needs, let alone assisting with cross-boundary development requirements. Further evidence is provided on this in other representations submitted by RPS.
