

The proposed Site 1 is of huge historical significance and to build on it would be tantamount to vandalism. The Council would be in breach of its statutory duty to protect the historic setting of the many listed buildings that border this site.

The beauty of the floodlit church would be lost if the sky was no longer dark because of the nearby development.

The site is fundamental to the village's identity. There are no other sites in the village that we rely on for our communal sense of identity and heritage.

The sense of wellbeing created by the tree bordered open horizon and dark sky is not a privilege reserved for a few – because of its position it benefits everyone in the village and all that pass through.

Development at this point would threaten to destroy the village's identity as a separate settlement because those leaving Leamington would be used to the urban sprawl extending from it e.g. Whitnash, Cubbington

Building on this open space within the village is short sighted and does not meet the statutory duty to plan in the long term interests of the village and District. It provides no option for future expansion.

If WDC does not discount Site 1 it will throw into question why the change from all previous planning decisions and processes which emphasized the importance of balancing historic and future needs.

Both the Parish Council and active developers have identified Site 2 (east of the village, south of the main road) as being feasible, acceptable and with potential to expand if necessary in the long term future. It was an error for WDC to discount Site 2 and it would be wrong to ignore the Parish Council's local knowledge and expertise. I support Site 2 because it

- provides a long term solution
- would not impact on the view from the Fosse, even accounting for several future expansions
- is capable of providing close and *safe* access for vehicles and pedestrians to village amenities
- represents an attractive location for access to the Fosse and M40, reducing the risk of new residents commuting through the heart of the village where congestion and dangers already cause problems
- is better in every respect than Site 1 and avoids the destruction of the best feature of our village
