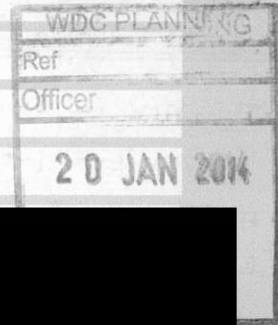

SITES 2 AND 3 SOUTH EAST OF THE VILLAGE OFF SOUTHAM ROAD

I AM IN SUPPORT OF SITES 2 AND 3 SOUTH EAST OF THE VILLAGE OFF SOUTHAM ROAD.

ALTHOUGH I AM UNCERTAIN ABOUT THE LEVEL OF LOCAL HOUSING NEED, THESE SITES DO NOT SEEM TO HAVE SUCH A HUGE IMPACT ON THE VILLAGE ITSELF. VEHICLE ACCESS WOULD BE MUCH SAFER THAN USING OFF CHURCH LANE, SCHOOL LANE AND CHURCH LANE. THESE ROADS ARE ALREADY CONGESTED AND HAVE EXPERIENCED MANY ACCIDENTS.

USING THE ABOVE SITES WOULD ALSO MAKE IT POSSIBLE FOR FURTHER EXPANSION IN FUTURE YEARS, RATHER THAN TARGETING THE CENTRE OF THE VILLAGE WHERE THERE WOULD BE NO ROOM WHATSOEVER.

THE VILLAGE SCHOOL AT PRESENT IS UNABLE TO ACCEPT ANY MORE PUPILS BUT IF THE ABOVE SITES WERE USED, THERE ARE SCHOOLS IN THE SURROUNDING AREAS WHICH ARE ONLY SHORT DISTANCES AWAY I.E. HARBURY, SOUTHAM ETC.
