- Developing the site will damage wildlife.
- The site is prone to flooding + will not enable ^{appropriate} drainage.
- The flooding causes hazardous conditions on Harbury Lane & so will increase the risk of accidents.

- The site is not cost effective to develop & relocated the football club - eg building homes plus 5-10 permanent pitches which cost between £325k to £650k.
