It is considered that the policy as drafted is unnecessarily restrictive and inflexible, and as a result the Plan will not deliver the level of windfalls required to meet the housing needs of the District. The Plan therefore is ineffective and unsound.

There is no sound justification for artificially limiting the scale of development to 2 dwellings as proposed by criterion a). Larger infill and other small scale schemes should be capable of consideration on a site-by-site basis without harm to the character of a village or to the Green Belt.

A review of the characteristics of the settlement form of Stoneleigh reveals that it is not solely of a linear nature and there are examples of development behind main road frontages, such as Church Lane. The requirement therefore in criterion b) that development should comprise the infilling of a small gap fronting a public highway is inappropriate in the case of Stoneleigh. In Stoneleigh it is considered that development could satisfactorily take place on land which does not front a public highway without harming the character of the village or the Green Belt.

It is considered that criterion c) is redundant in that the impact of proposed development is to be considered under other policies of the Plan.
