In not doing this the proposed modification does not meet the NPPF requirements under:

154. setting out the opportunities for development and clear policies on what will or will not be permitted and where; 155. reflect a collective vision and a set of agreed priorities for the sustainable development of the area,

157. Crucially, the plan does not plan positively for the development and infrastructure required in the area.
