Our client considers that land to the east of Cromwell Lane should be removed from the Green Belt.

Paragraph 83 of the National Planning Policy Framework (the Framework) establishes that "Local planning authorities with Green Belts in their area should establish Green belt boundaries in their Local Plans which set the framework for Green Belt and settlement policy. Once establishes, Green Belt boundaries should only by altered in exceptional circumstances, through the preparation or review of the Local Plan." As currently drafted the proposals map retains our clients land as within the Green Belt. It is clear that the land in this location does not meet the five purposes of the Green Belt as established in the National Planning Policy Framework and therefore in line with the guidance set out at paragraph 83 of the Framework now is the most appropriate time for the site to be removed from the Green Belt.

Should the Council not remove sufficient land from the Green Belt, or make changes that reflect the timespan of the Plan, at this stage of the process we consider that this could lead to a further review of Green Belt boundaries in the near future. This is contrary to Government policy which establishes that Green Belt boundaries should only be altered in exceptional circumstances.
