The developments referred to in paragraph 2.49 are shown on the map enclosed in **Appendix 1**. Crossreferencing these with the spreadsheet enclosed in **Appendix 2** demonstrates that they have all contributed to the expansion of the police infrastructure required to support them.

The information contained within the aforementioned appendices confirms that the methodology used by Place Partnership Limited (PPL), on behalf of the police, for Section 106 requests in Warwick District is compliant with the Community Infrastructure Levy (CIL) Regulations.

To evidence this point, **Appendix 3** contains a summary of three recent appeal decisions. These are from January and February 2016 and therefore very up-to-date. In all three cases, the Secretary of State agrees with his Inspector that developer contributions towards the cost of police premises and equipment are CIL compliant.

'...The area will deliver extended secondary school facilities, three primary schools, local GP services, **police infrastructure**, shops, community facilities and an important buffer of open space to the south to be delivered as a Country Park.'
