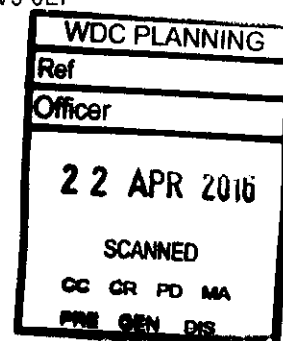

The modification plans with increased housing numbers have been issued without proper consultation with the local community and without regard to the burden on the existing infrastructure. No definite assurance of what will be done prior to any development for improving - the local road network, safety from increasing accidents in the H28 blackspot area (A4177) - easing the traffic congestion or overcoming the existing poor drainage issues and addressing the poor air quality from this main road area. A new access road on the notorious road bend for example is a crazy & ill thought out suggestion (to H28) no school accommodation or health service is included and no identification of open spaces given. No plan given for the layout of housing. No regard whatsoever for the Greenbelt or long term sustainability

Commonsense should rule over how many homes should be safely sited in locations H28 & H53. Regard should be given to the fact that the A4177 is an already highly congested main route into historic Warwick. Regard to a sustainable development style in the Greenbelt and the Town's of area to support the main town not destroy it & listen to local people
