Please see attached letter from the Parish Council.
We believe that the total number of new dwellings proposed for DS3NEW, the former Warwickshire Police HQ, as shown on page 35. is too high at 115. This risks potential damage and disturbance to the setting of the Grade 2 listed manor house, Woodcote.
The Parish Council's analysis, based upon expert technical support, suggests a (23.5%) lower figure at 88 in total. Detailed layouts taking account of the need for a varied mix and scale of properties, whilst preserving the aspects and setting of the house and its gardens, have been prepared in support of this number.

A reduction in the number of new dwellings proposed for DS3 NEW on page 35 of the amendments to 88 will provide the solution. The number of new dwellings proposed for area H37 could, meanwhile, be increased to 15, bringing the overall number for the village of Leek Wootton up to 103. The Parish Council considers that this number will be sustainable within the overall context of the Local Plan.
