(1) I moved to Hatton Park to be closer to my place of work in the centre of Warwick. Although only 3 miles, I have been shocked and disappointed by the sheer volume of traffic along the main A477 Birmingham Road in both directions and regularly encounter delays en route. I do not believe that the current infrastructure supports the proposed increase in traffic volumes that will inevitably arise from this proposed development. I further believe that the increase in traffic and access to side/back roads, such as Ugly Bridge Road, will pose further dangers on an already notorious accident hotspot.

## Section 7 continued:

- (2) I do not believe that the proposed access point to the new development, i.e. via Bazehston Drive, is either safe or sound. Large vehicles, including the local bus, already struggle to manoeuvre around the traffic calming points and the likelihood of damage to both verges and pathway must be significant, should lorries and heavy plant have to enter Hatton Park from this point.
- (3) Whilst provision of schooling is no longer a <sup>direct</sup> personal concern, as a former teacher, I would have serious concerns about how existing provision of school places could accommodate the proposed increase in potential numbers and I am additionally concerned and potentially affected by the knock-on for all other associated services, including GP provision and local amenities. In particular, I have obvious concern for Hatton Park Village Hall and the children's playground next to it which would inevitably be affected by making access to the proposed development adjacent to them. This must surely result in a less safe area for local children.
