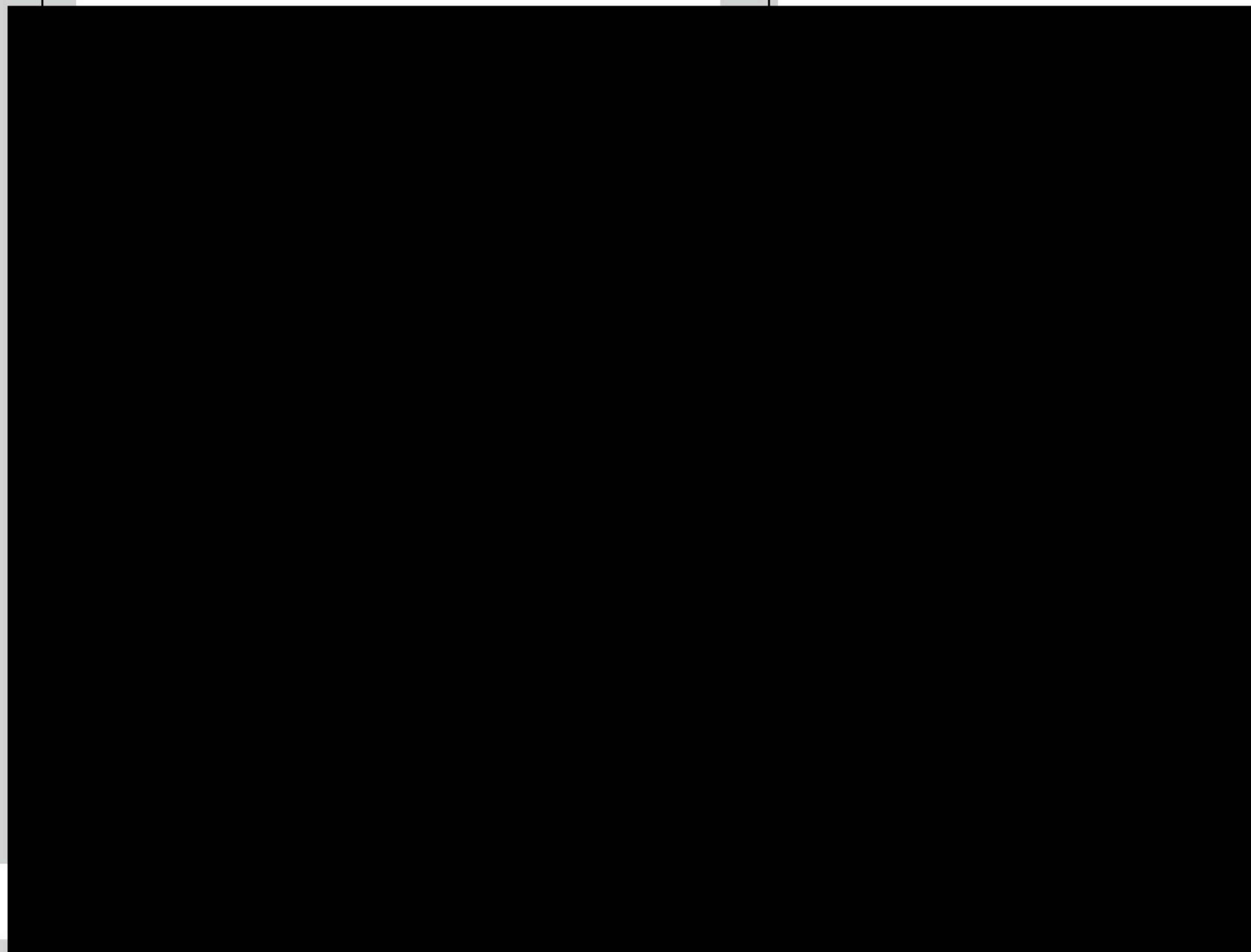

**Proposed Modification Unsound - because it is NOT**

**1. Positvely prepared**

- It was the result of a rapid response to the Inspector's initial report that the Local Plan was not 'sound' because of lack of co-operation over Coventry's unmet housing numbers.
- Rugby has only 289 people per sq.Km and North Warwickshire has 211 and those areas could accommodate Coventry's unmet housing and yet WDC accepted the high number.
- The original Local Plan did not mention Kings Hill and the decision to use King's Hill was not known before the Council meeting on Feb 24th.

- Reduce the housing numbers to a maximum of 200 in the first phase with no more than a total of 500 in the future. This can be achieved by other areas with brown field sites and space taking on Coventry's unmet housing needs.
- Make the Coventry owned land in Warwickshire a permanent Green Belt to maintain a green space between Kenilworth and Coventry.
- Remove the whole of Wainbody Wood from future planning.
- Build small groups of houses that will fit into the preserved areas of the site.
- Leave the fields adjacent to Green Lane as farmland on Green Belt
- Remove plans for a railway station as the distance between Coventry and new station does not merit two stations. A park and ride bus service at Coventry Station would provide for University.
- These will make the Local Plan sustainable
