

IF THE GREEN BELT LAND TO THE NORTH OF LEAMINGTON AND MILVERTON IS TO ACCOMMODATE OVERSPILL HOUSING FOR COVENTRY THEN THIS LAND SHOULD BE ADJACENT TO COVENTRY, AS I BELIEVE THEIR OWN LOCAL PLAN STATES, RATHER THAN REDUCING THE 'GREEN LUNG' BETWEEN LEAMINGTON AND KENILWORTH. THERE IS HOWEVER NO WAY OF ENSURING THE NEW HOUSING GOES TO COVENTRY RESIDENTS / WORKERS AND NOT INTO THE 'POOL' OF 'INTERNATIONAL' HOUSING. ADDITIONAL HOUSING SHOULD BE EITHER NEXT TO COVENTRY OR TO SOUTH OF LEAMINGTON FOR OUR DEVELOPING INDUSTRY, NEXT TO THE M49, NEXT TO THE RAILWAY AND NEXT TO THE MAJOR SHOPPING SUPERMARKETS. THE PARK AND RIDE WILL NOT WORK UNLESS IT IS A DEDICATED BUS SERVICE.
