Warwick District Council has received the submission draft of the Baginton and Bubbenhall Neighbourhood Plan. The consultation on this plan commences on Friday 9th June at 16:45 and will run for a period of 6 weeks ending at 16:45 on Friday 21st July.

An independent Examiner will then be appointed and the examination will commence when the documents and any representations received to this consultation are passed to the Examiner.

Once the examination has concluded and the report of the Examiner is received, any recommendations will be considered and a referendum will follow in due course. If more than 50% of the vote is in favour of the plan, Warwick District Council will 'make' the plan and it will become part of the Local Development Plan, being taken into consideration when decisions are made on planning applications.
