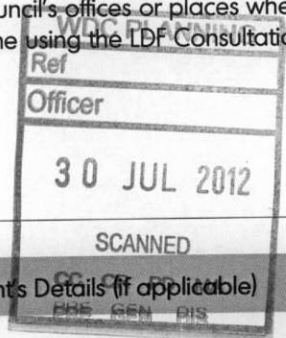

HOWEVER PO17 MAKES NO REFERENCE TO HOW IT IS GOING TO PROVIDE POLICY PROVISION TO ENABLE THE DELIVERY OF NEW COMMUNITY INFRASTRUCTURE FOR THE VOLUNTARY SECTOR IN GENERAL AND THE FAITH SECTOR IN PARTICULAR.

WHILE IN PRINCIPLE PO13 MEETS THE NEEDS FOR CREATING INCLUSIVE, SAFE + HEALTHY COMMUNITIES. I FEEL THAT THERE ARE SOME VITAL AREAS NOT COVERED.

SCHOOLING: I FEEL THAT WDC SHOULD ADOPT PARAGRAPH 72 FROM THE NPPF AND INCLUDE IT IN PO13 ALONG WITH DETAILS OF HOW THEY PROPOSE TO DELIVER ON IT.

IT DETAILS THAT IN ENSURING LOCAL COUNCILS OFFER "SUFFICIENT CHOICE OF SCHOOL PLACES ... TO MEET THE NEEDS OF EXISTING AND NEW COMMUNITIES" THEY SHOULD "WORK WITH SCHOOL PROMOTERS TO IDENTIFY AND RESOLVE KEY PLANNING ISSUES" AND ALSO "GIVE GREAT WEIGHT TO THE NEED TO CREATE, EXPAND OR ALTER SCHOOLS".

THIS IS ESPECIALLY IMPORTANT GIVEN THE GOVERNMENT'S PROMOTION OF FREE SCHOOLS, AND IT SHOULD BE RECOGNISED THAT WDC ARE IN ACCORD WITH THIS.

FAITH: I FEEL THAT THERE IS A NOTICEABLE ABSENCE IN REFERENCES TO FAITH AND HOW IT IS LINKED TO SAFE AND HEALTHY COMMUNITIES. AS A CHRISTIAN I FEEL THAT RECOGNITION SHOULD BE MADE TO THIS FUNDAMENTAL LINK AND THAT WDC SHOULD MAKE STRONG AND DEFINATE POLICY WHICH ALLOWS FOR THE ACTIVE PROMOTION OF FAITH IN OUR COMMUNITIES. THIS WOULD INCLUDE PROVISION FOR PLACES OF WORSHIP IN ALL NEW AND EXISTING DEVELOPMENTS.
