This submission is made on behalf of Court (Warwick) Ltd in the context of the designation of Stoneleigh as a Category 3 village.

It is submitted that Stoneleigh should reasonably be included in the list of villages under Category 2, for a modest scale of development as an expansion to the village framework. Stoneleigh is well located to Stoneleigh Park which is identified as a Major Developed Site in the Green Belt within the adopted Local Plan – and is the subject of a planning application for substantial employment development.

A modest expansion of Stoneleigh would provide an opportunity albeit limited, for some people to live close to their place of employment at Stoneleigh Park. Furthermore, Stoneleigh is well located to larger centres of population, including Kenilworth, Warwick and Leamington, involving short journey to access schools, shops and other places of employment and leisure facilities.

The plan attached to these submissions identifies an area of land that could accommodate circa 14 dwellings. It is submitted that this release of land from the Green Belt would not adversely impact upon the underlying purposes for the Green Belt. The extent to which encroachment into the Green Belt would occur is of limited consequence on account of the relationship of this site to the existing urban edge of Stoneleigh.
